**GasLog Partners LP Announces Public Offering of Series A Cumulative Redeemable Perpetual Fixed to Floating Rate Preference Units**

MONACO, May 8, 2017 -- GasLog Partners LP (“GasLog Partners,” the “Partnership” or “we”) (NYSE: GLOP) announced today that it plans to offer its Series A Cumulative Redeemable Perpetual Fixed to Floating Rate Preference Units, liquidation preference \$25.00 per unit (the “Series A Preference Units”) in a public offering under its effective shelf registration statement. The Partnership intends to grant the underwriters a 30-day option to purchase additional Series A Preference Units from the Partnership. The Partnership intends to file an application to list the Series A Preference Units on the New York Stock Exchange.

The Partnership plans to use the net proceeds from the public offering for general partnership purposes, which may include future acquisitions, debt repayment, capital expenditures and additions to working capital. We currently expect that this will include future acquisitions from GasLog Ltd., our parent (“GasLog”).

Morgan Stanley, UBS Investment Bank and Citigroup are acting as joint book-runners for the offering, Stifel is acting as lead manager for the offering, and ABN AMRO and BNP PARIBAS are acting as co-managers for the offering.

The offering is being made only by means of a prospectus. A copy of the preliminary prospectus relating to the offering may be obtained from Morgan Stanley & Co. GasLog Partners is a growth-oriented master limited partnership focused on owning, operating and acquiring LNG carriers under multi-year charters. GasLog Partners’ fleet consists of ten LNG carriers with an average carrying capacity of approximately 152,000 cbm, each of which has a multi-year time charter. GasLog Partners’ principal executive offices are located at Gildo Pastor Center, 7 Rue du Gabian, MC 98000, Monaco.
